### MANAGER ACTION ITEMS:

- Attended the Building and Grounds Committee meeting on May 12th.
- DR Paint has painted the posts and lamps at the tennis courts and Dog Park.
- Sharon and I will begin the process of determining which lots need to remove and replace trees that are dead.
- Contacted Steve Autry with Advance Exercise Equipment regarding delivery of the bicycles and he is anticipating delivery sometime between Wednesday and Friday of this week.
- The annual tree pruning has been completed.
- The trees have been trimmed and debris removal completed at the Pontebella Cul-da-sac as requested by Michael Frank for the survey engineer to obtain accurate readings.
- An e-mail was received from Park Pro along with a letter from the City of Scottsdale stating that by July 1<sup>st</sup> due to revised fire code 4045 section 502.7 that the installation of a key switch and pre-emption sensor shall be required on all electric entry controlled security gates across a fire apparatus road. The cost is \$1,738.64. The proposal has been signed and forwarded to Park Pro.
- The camera at the entrance lane has been installed.
- All bulletin boards have had the cork board replaced and all were sealed.
- Erosion repair at lot 5010 is to be completed by the end of June.
- Repair to the existing Lone Mountain trail, signage and additional trail heads are under discussion with the Building and Grounds Committee.
